- 3. GST Payable and TDS Payable is subject to reconciliation and payment to Government.
- 4. Association is registered u/s 12AA(1)(b)(i) of Income Tax Act 1961 as per Order: OGE No. CIT(E)/AAAAG2315D/12AA/TRO (E)/2019-20/dated 27.02.2020 as Charitable Trust and no income tax provision has been made in the books of accounts for the current year as total contribution has been applied for the objects of the trust.
- 5. Insurance claim lodged for the One Day International match (24th Oct 2010), which was abandoned due to rains/wet pitch, is yet to be settled and same has not been accounted.
- 6. Balances in sundry debtors, loans and advances, deposits and sundry creditors are subject to confirmations and/or reconciliations as completion of consequential adjustments, if any will have to be made.
- 7. An advance from BCCI to GCA that earlier had a probability that it may be considering for processing by BCCI during March 2020 was considered for processing by BCCI during April 2020. GCA has accordingly raised the invoice on BCCI during FY 2020-21 and accounted accordingly after receiving confirmation of consideration for processing of Rs 5 Crores from BCCI.



- 8. The Association has filed for application for the settlement of disputes under the Vivad se Vishwas Scheme 2020 with the Income Tax Department. Currently the matters are pending for confirmation with the Income Tax Department.
- 9. Inventories of sports goods are valued at cost. As per earlier practice inventories were directly charged off to Income and Expenditure account. However now closing stock of sports inventory of Rs 57,92,241/- has been shown as a Current Asset in the Balance Sheet. The effect of showing closing stock of sports inventory of Rs 57,92,241/- has resulted in increase of Income by Rs 57,92,241/- in the Financial Year 2019-20.
