# MINIMUM ELIGIBILITY CRITERIA FOR BIDDERS: TECHNICAL CRITERIA:

The bidder should have in the <u>last 7 years ending 31<sup>st</sup> October 2021</u> successfully completed as a prime contractor, with Govt bodies and / or with Reputed Large Private or Public Limited Companies, at least one similar work with minimum fleet of equipments as desired under schedule B of Tender Document.

The term similar work means the work involving with earthwork in excavation & embankment.

The attested copies of original **work orders** and **completion certificates** indicating final cost of total work, Actual cost of the component related to the similar work of this tender document, date of commencement & completion, the scope of Work.

Attested copies of GST Invoices issued and TDS Certificates as a proof of work are required to be submitted in addition to other documents for works related to Reputed Large Private or Public Limited Companies. This is to ascertain the quantum of similar work completed for the Reputed Large Private and Public Limited Companies

The Completion Certificate issued by the clients should be submitted along with the bid. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of the Tender.
